- 1. This promotion only applies to holders of a BEA Credit Card. The BEA Corporate Card is excluded.
- 2. A computer system will be used to calculate cash rebates. The records of The Bank of East Asia, Limited ("BEA") shall be final and conclusive. Cash rebates are not transferrable and will be rounded up to the nearest Hong Kong dollar.
- 3. All eligible transactions must be conducted during the promotional period, based on the transaction date.
- 4. Eligible transactions include 2016/2017 Salaries Tax and Personal Assessment payments made using the Cyberbanking "Payments Bills" function. Payments of other taxes (including but not limited to Property Tax and Profits Tax), scheduled payments whose execution dates do not take place during the promotional period, and all other online bill payments are excluded.
- 5. The eligible account must be valid during the promotional period and at the time the cash rebates are given.
- 6. No Bonus Points will be granted for the tax amount paid.
- 7. Un-posted/cancelled/refunded transactions and transactions that are found fraudulent or eventually cancelled/refunded will be considered ineligible.
- **8.** If a transaction proves to be ineligible, BEA shall be entitled to debit an amount equal to the value of the cash rebate from the designated principal card account.
